



RANCH LIABILITY WAIVER

Release of Liability, Waiver of Claims, Assumption of Risks, and Indemnity Agreement

PLEASE READ CAREFULLY BEFORE APPROVING

Inherent Risks: I, the undersigned, acknowledge and understand that participation in activities at Animal Ranch LLC (the "Ranch") involves inherent risks, dangers, and hazards, including but not limited to, the unpredictable nature of horses, cows, donkeys, birds and/or all animals on our ranch the potential for personal injury, accidents, illness, or death, and property damage. These risks may result from the actions or inactions of myself and others, the condition of the facilities or equipment, and the behavior of the animals.

Assumption of Risk: I freely accept and fully assume all such risks, dangers, and hazards, and the possibility of personal injury, death, property damage, or loss resulting therefrom. I understand that these risks may arise from the unpredictable behavior of horses and other animals, which may include kicking, biting, stumbling, rearing, shying, or bolting. **Release of Liability:** In consideration of being permitted to participate in activities at the Ranch, I hereby voluntarily release, waive, and discharge Animal Ranch LLC, its owners, employees, agents, and representatives (the "Released Parties") from any and all claims, demands, causes of action, or liability for any loss, damage, injury, or expense, including legal fees, arising out of or in any way connected with my participation in activities at the Ranch. **Indemnity Agreement:** I further agree to indemnify and hold harmless the Released Parties from any and all claims, demands, causes of action, or liability for any loss, damage, injury, or expense, including legal fees, arising out of or in any way connected with my participation in activities at the Ranch, or due to any act or omission of myself or any minor for whom I am responsible.

I have the right to disapprove Basic Medical Treatment: In the event of an emergency, I authorize the Ranch and its representatives to obtain medical treatment for me, or any minor participant for whom I am responsible, and I agree to bear the costs of any such treatment if any.

Photo/Video Release: I consent to the use of any photographs, video recordings, or other media taken of me during my time at the Ranch for promotional or commercial purposes, without compensation. **Acknowledgment of Understanding:** I have read this release of liability and assumption of risk agreement, fully understand its terms, and understand that I am giving up substantial rights, including the right to sue. I acknowledge that I am signing the agreement freely and voluntarily, and intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.

Rules & Regulations:

Be advised: Children/Teens must always be accompanied by an adult. No children are allowed to be dropped off or left unattended.

Weather: All sales are final and nonrefundable. If you purchase a ticket and the weather gets bad, you can use that ticket another day. It needs to be approved by management with a stamp or email confirmation.

No Re-entry Permitted: After you enter the premises on that day and decide to leave, you cannot reenter unless you purchase another ticket.





Waivers: All ticket holders need to sign waivers, no exceptions. Parents or legal guardians (children under the age of 17 years) will need to fill out the waiver, naming each child they bring with them.

Misconduct: We have the right to refuse to accept any person who does not follow the rules or policies as instructed on the waiver or advised by management. Any unruly child/person will be asked to vacate the premises at any time and will lose the right to re-enter the premises again in the near future.

I am the main person authorizing this Liability Waiver, and I am responsible for the actions and well-being of all the guests I bring with me to this event. I am either the guardian/parent of under age noted below.
